Charles S. Hyneman, past president of the American Political Science Association, is distinguished professor of political science emeritus at Indiana University. His writings include the widely acclaimed *Bureaucracy in a Democracy*, *The Supreme Court on Trial*, and (with Charles E. Gilbert) *Popular Government in America*. Currently he is engaged in study of the pamphlet literature of the founding period of the American republic.

Stephen J. Tonsor, professor of intellectual history at the University of Michigan, is the author of *Tradition and Reform in Education*. He has published widely in both scholarly and popular journals and is regarded nationally as a principal spokesman of conservatism. Currently he is resident scholar at the American Enterprise Institute and is doing research for a definitive work on the idea of equality.

George W. Carey is professor of government at Georgetown University, editor of *The Political Science Reviewer*, and editorial advisor of *Modern Age*.

Arthur Shenfield, British economist, writer, and barrister-at-law, has been regents' professor of economics at the University of California and visiting professor at the Universities of Chicago, Dallas and San Diego, and at Temple University. He resides in Old Windsor, Berkshire, and is a past president of the Mont Pelerin Society. This article was presented as a paper to the Mont Pelerin Society meeting in Madrid in September, 1979.

Rod Preece is professor of political science at Wilfrid Laurier University, Ontario. He has written two books on German politics and has contributed articles on various aspects of conservatism to the *Canadian Journal of Political Science*, the *Canadian Journal of Political and Social Theory*, and *The Eighteenth Century*. He is a riding vice president of the Canadian Conservatives.

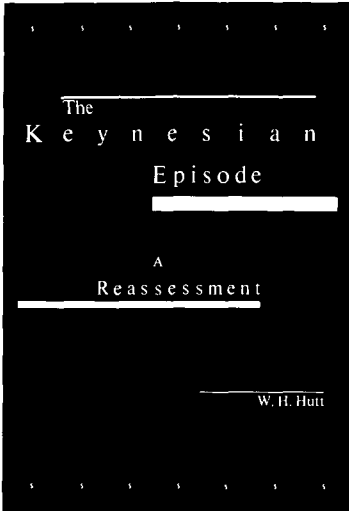
